- Member Secretary informed the house that as per the instructions of the committee, the result of First year and Second year was declared with the permission of Hon. Chairman..
- Member Secretary presented the result analysis of the Summer 2018 and Summer Term 2018 examination showing the percentage passing and failure.
- Prof. Kakade appreciated the results of all years as failure % is less than 20%. But he expressed his deep concern regarding higher % failure of F.Y B.Tech students of Electronic and Telecommunication Engineering and Information Technology.
- Regarding the reasons of failure and remedial measures to improve overall result, Dr. S.S.Dambhare suggested and stressed to carryout academic and question paper audit.
- Dean academic, Dr. U.V.Patil informed the house the ongoing process of academic and question paper audit.
- Prof. Kakade expressed his expectation to set question papers, based upon Bloom's Taxonomy, and make it a regular practice.
