
- 3.2 Corrections, if any, shall be made by crossing out, initialing, dating and re writing.

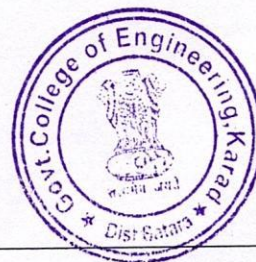
