





- The Academic Council noted the closure of the M.Tech Heat Power Engineering programme with effect from Academic Year 2025–2026.



 In the Academic Year 2024–2025, audit courses aligned with institute-level Multi-Disciplinary Minors (MDM) and Open Electives (OE) were offered to all final year B.Tech programmes. In A.Y. 2025-2026 institute offered audit courses aligned with

MDM and OE as a part of the curriculum structure. The planned capacity of MDM and OE is 100 seats; but there is no response from the final year B.Tech students. So from the Academic Year 2025–2026, these courses will no longer be offered as audit course to the final year B.Tech programmes. It is also decided to revise curriculum structure of all final year B. Tech accordingly. In addition to that it is decided to offer MDM and OE courses exclusively to NEP admitted students in Second Year and Third Year B-Tech from A.Y. 2025-2026. The Academic Council noted and approved this change.
