- 1) Dr. Mrs Subramanyam asked to consider at least 1 credit for FE 2209, Basic Engineering course by reducing w/s credit by 1
- 2) It was suggested to allot tutorial hours only if lab is not allotted to a particular course. This was discussed in connection with FE2202 course, Chemistry.
- 3) It was brought to the notice that sum of contact hrs of FY B. Tech. Sem-II, on page No. 22 has to be corrected to 28.
- 4) Hon. Members asked to retitle the FE2204 course 'English' as 'Professional Communication'.
- 5) Members suggested to give contents of induction program.
- 6) Course Outcomes (COs) are to be given for every course curriculum content.
- 7) Members suggested to introduce a course 'Introduction to Engineering Profession' at first year level to give insight of Engineering.
- 8) One core subject can be added by adjusting credits of other subjects wherever possible.
- 9) One mandatory audit course in every semester.
- 10) Open Elective courses may be offered to all other programs
