Member Secretary welcomed all the members and requested Hon. Chairman to offer opening remarks. Hon. Chairman, Dr. P. M. Khodke, also welcomed the members and reviewed the examination activities conducted under autonomy. After opening remarks by Hon. Chairman, Member Secretary initiated the proceeding with the permission of chair. The following business was transacted in the meeting.

To report actions taken on the minutes of second meeting of Examination Committee held on 26.10.2016

Member Secretary presented the action taken report on the minutes of Second meeting of Examination Committee. The house gave following suggestions.

• While discussing action taken report, Prof. Kakade suggested to organize one week Symposium or workshop at Govt. College of Engineering, Karad for implementation of choice based credit system (CBCS). The workshop should also include on quality of question paper setting (considering due weight-ages for different skills). Hon chairman suggested to incorporate inclusion of evaluation of accreditation parameters (PO) in the workshop. He further suggested to have panel discussion and question answer section. The workshop shall be organized in collaboration with University and Directorate of Technical Education. All faculty of institute, all external examiner from panel, and faculty from autonomous institute in the State may be invited for the workshop. Hon. Chairman instructed Member Secretary to inform Dean Academic to organize the Symposium regarding question paper setting in summer vacation.

With the above suggestions, the house noted the action taken report on the minutes of second meeting of Examination Committee held on 26.10.2016.

Item No. 3.3

To accord post facto approval to the results of Winter-2016 Examination

Member Secretary presented the details of activities of ESE Winter 2016 Examination.

- Member Secretary informed the house that as per the instructions of the committee, the result of First year was declared with the permission of Hon. Chairman. For Second year the meeting is being conducted after First year examination.
- Member Secretary further informed that there is delay in declaration of the results as per academic calendar. The reason for delay in result declaration is due to grade moderation carried out after the revaluation. This has happened due to misinterpretation of the Rule 24 of Ordinance and Rule and Regulation for UG programmes. The rule says that, "the facility of revaluation shall not be available after grades are finalized". In order to follow the rules and protect the interest of students applying for revaluation, the declaration of entire result was delayed. He further requested the house to confirm the interpretation.
- Hon Chairman opined that delay in declaration of results due to revaluation process should not affect students who pass the examination and do not apply for revaluation. The schedule of declaration of result (within 8 days after conclusion of ESE) should not be disturbed because of revaluation process, since revaluation is an additional facility for the students.
- House unanimously resolved that the word 'Grade', while providing facility of revaluation, is applicable to the students applying for revaluation'. Hence there should not be any problem in declaring results of other students.
- · In this regard, the house has issued direction as follows:
 - 1. Grade moderation of a particular course should be carried out by excluding the students who applied for revaluation in that course and the result of all the students, except those applied for revaluation, should be declared. The declaration should be in terms of making grade cards available. It will certainly need the processing of results through MIS and preparation of provisional R 08.
 - The grade cards (unsigned) should be made available on students ID thorough on students log in on website. The students can download the card and take

- print. The official print copy should be issued as per schedule (excluding revaluation cases) which will only be treated authentic.
- 3. After revaluation process is completed, the necessary corrections for revaluation cases be made manually and final R-08 should be published. For manual corrections, only CoE is authorized who should do it through his login. The grade cards for revaluation cases should be issued only after R08 is finalized.
- Hon Chairman also instructed Member Secretary to convey the appropriate date of meeting of Examination Committee to Coordinator of Academic Calendar for next year, so that the meeting shall be conducted before declaration of results.
- Member Secretary presented the result analysis of the Winter 2016 examination showing the percentage passing and failure.
- Prof. Kakade expressed his concern about percentage failure in few subjects. House
 unanimously decided to issue the letter to the faculty were failure is 20% or more
 asking the reasons and remedial measures to overcome the issue and put their
 submission in the next meeting. The subjects are as follows,
