Reference: Committee formed for updates in Revaluation Rule R4.6 as per Order No GCEK/Dean Academics/ Exam R.R./2980 dated 23-09-2025

As per above reference a meeting of all committee members was held on 6th Oct 2025. Following are the minutes of meeting –

It is discussed that there is typo mistake in framing of Revaluation Rule in published "Rules of Examination for NEP-2020 UG & PG Programs" Rule 4.6 and "Ordinance and Regulations for PG Programs" Rule R21.1.

The committee members discussed the issue and resolved that above rules should be read as below -

Revaluation of Answer Books (R4.6 and R21.1)

The provision for obtaining a photocopy and applying for revaluation is regarded as a special facility and not a right in the strict sense of the term.

A student aggrieved by the End Semester Examination (ESE) marks declared may apply to the Examination Cell for revaluation of an answer book within three days after the marks are displayed in the MIS login. The application must be accompanied by the prescribed fees. The Controller of Examinations (CoE) shall appoint an appropriate examiner for the revaluation. For Mid Semester Examinations (MSE), students shall be allowed to see the evaluated answer paper, and any conflict regarding re-totaling shall be resolved at the departmental level by the Head of the Department.

The revision of marks after revaluation of an ESE answer book shall be governed by the following conditions:

After revaluation, a change in marks will only be considered if the variation between the original marks and the revalued marks is \pm 5% or more of the maximum marks assigned to that paper.

- If the change is 5% or more but not greater than 15%, the final marks awarded to the student shall be the maximum of the original marks and the revalued marks.
- If the change in marks after revaluation is greater than 15% of the prescribed total marks, the answer paper shall be reassessed by a third examiner (re-revaluation). In this case, the final marks shall be the maximum of the three scores obtained.
- All cases where the change in marks after revaluation is greater than 25% must be reported to the Chairman of the Examination Committee (EC).

The above changes in Revaluation rules to be considered as Amendments in Examination Rules and Regulations and to be displayed on College Website.
