Item No. 3.3

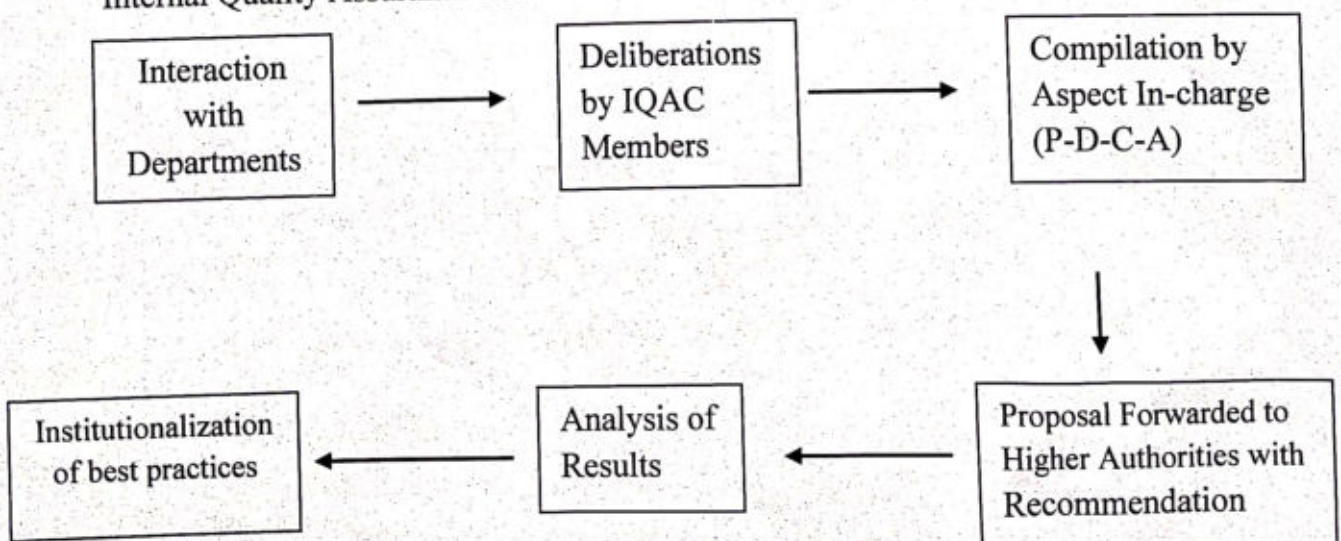
To Discuss and recommend Models of Quality Assessment to be followed by Institute.

Hon. Chairman proposed following Organizational methodology to be adopted by Internal Quality Assurance cell.












