3. Students have to take permission of respective HoD's and submit it to MIS section. (In no case student is allowed to re-register without prior permission)
4. Re-registration charges are Rs. 1300/- (Rupees One Thousand Three Hundred only) per course as per norms.
5. **The dates of re-registration for backlog courses examination are 03<sup>rd</sup> Oct., to 05<sup>th</sup> Oct., 2023**
