Saturdays and public holidays may be used to conduct Mid Semester Examinations and Semester End Examinations. However, effort is normally to be made to exclude Sundays for mandated academic activities, including examinations. • The department will be responsible for conducting 90 days of academic activity within specified term period. If 90 days are not completed use of Saturdays/Sundays and public holidays is recommended.
